

TERMS AND CONDITIONS
“OFFER AT LAZADA.VN WITH HSBC CREDIT CARDS
IN AUGUST, 2017” PROMOTION

1. The “**OnlineOffer at Lazada.vn with HSBC Credit Cards in August, 2017**” Promotion (“**Promotion**”) shall be effective from 15 August 2017 to 29 August 2017 (“**Promotion Period**”).
2. There are 3 promotional weeks, and 3 promotional days in total during the Promotional Period (“**Promotional Month**”, “**Promotional Week**”, “**Promotional Day**”).

3. The Promotion is applicable for cardholders (“**Eligible Cardholders**”) who meet all the following conditions:
 - a. Holders of these credit cards issued by HSBC Bank (Vietnam) Ltd. (“**HSBC**”):
 - HSBC Premier World MasterCard®
 - HSBC Visa Platinum Credit Card
 - HSBC Visa Gold Credit Card
 - HSBC Visa Classic Credit Card

(These credit cards shall be referred to as “**HSBC Credit Cards**”)

Note: The Promotion is not applicable for HSBC Business Credit Card.

- b. Cardholders will not be eligible for this Promotion if his / her Credit Card is delinquent, blocked, or inactive at HSBC.
 - c. Cardholders who hold membership accounts at www.lazada.vn
4. Promotion Details:

4.1 This Promotion applies to online purchases made on HSBC Credit Cards at at www.lazada.vn/hsbc-q32017

4.2 Offer:

- a. In each Promotional Day, the first **170** Eligible Cardholders whose orders are settled with HSBC Credit Cards and valued at least VND 1,000,000 will be entitled to a discount of VND 200,000 with **promotion code HSBCQ3** (“**Offer**”).
- b. Each Eligible Cardholder may only receive the discount once during each Promotional Week.

- c. The Promotion applies to 510 Eligible Cardholders during the Promotion Period. Eligible Cardholders will not receive the discount when the number of assigned discounts in each Promotional Week run out.
- d. Any remaining discount offers from the previous Promotional Week will be accumulated for the following Promotional Week.
- e. HSBC and Lazada will provide instructions on how customers may obtain the discount on www.hsbc.com.vn and www.lazada.vn from 15 August 2017.
- f. Applicable for all products on www.lazada.vn, except formula milk, Vinamilk and non-promotional products as determined by Lazada.
- g. Not applicable at the same time with other promotions, promotion codes and HSBC 0% interest Installment Plan.
- h. The promotion only applies for retail customers, not for wholesale.

4.3 How to receive the discount:

- a. The Eligible Cardholder must sign in/sign up their member accounts at www.lazada.vn
- b. At the payment stage, the Eligible Cardholder must follow instructions as shown on www.hsbc.com.vn and www.lazada.vn to be entitled to the VND 200,000 discount.

4.4 Additional conditions:

- a. The discount cannot be converted into cash or cash back into any credit card account or transactional account of the Cardholder.
 - b. Purchases www.lazada.vn/hsbc-q32017 will be subject to terms and conditions of Lazada.
 - c. The Cardholder may be requested by HSBC to provide the financial invoice and relevant supporting documents to prove that the transaction is eligible. In case the Cardholder does not or fails to prove that the transaction is eligible, HSBC reserves the right to deduct his/her transactions from the value of eligible purchase transactions.
5. In case of any dispute related to this Promotion, HSBC shall resolve disputes in cooperation with the customer. If the parties fail to reach an agreement, disputes will be resolved in accordance with Vietnamese laws.
6. HSBC reserves the right to amend these Terms and Conditions at any time without prior notice to customers, after completing necessary procedures as required by law.
7. These Terms and Conditions are available in both English and Vietnamese versions. In case of any discrepancy or inconsistency between the English version and Vietnamese version, the Vietnamese version shall prevail.
